I acknowledge and understand that application to become a firefighter with South Wall Fire Rescue and Wall Fire District 3 requires the following commitment:

Selected applicants will be subject to a 12-month probationary period with review after six (6) months. The following must be completed or accomplished during the 12-month probationary period:

During the initial one (1) year term, all probationary members are required to attend, at a minimum:

- Twenty-five percent (25%) of all emergency calls;
- Twelve (12) of the last twenty-four (24) training drills;
- Eight (8) of the last twelve (12) consecutive Company meetings; and
- Six (6) of the last twelve (12) administrative assignments;
- Demonstrate continuous fort to become more proficient in general firefighter duties, improving operational skills with all firefighting, rescue and emergency medical tools for which training has been received, decreasing response times and working cooperatively and jointly to provide quality service to the protection district;

There will be additional training required to attend before becoming a regular member of this fire company:

1. Start NPPA 1403 Basic (Essentials) course within the first two (2) years
2. Additional training for specialized teams.

Being a firefighter is an emotionally challenging job and provides you with self-respect and self-satisfaction. Firefighting requires training and demands team effort and respect from each individual firefighter in the Department.
